## **VALUE ADDED TAX, IMPORT DUTY & POSTAL ARRANGEMENTS**

**THERE IS NO VAT or IMPORT DUTY FOR CUSTOMERS RESIDENT IN UK  
(including NORTHERN IRELAND) OR IN REPUBLIC OF IRELAND**

UNITED KINGDOM (INCLUDING NORTHERN IRELAND): all items posted using Royal Mail, fully insured, signed for, registered post. Please note that NO VALUE ADDED TAX or import duty will be payable by purchasers from the UK.

U.S.A.: THERE IS NO IMPORT DUTY PAYABLE ON NUMISMATIC ITEMS (coins and medals) - so you will not have to pay any import taxes if purchasing from my list.

AUSTRALIA, CANADA AND NEW ZEALAND: The authorities in these three countries do not generally charge duties on items of low value (for instance, medals with a declared value of \$100 and under), but higher value items may attract import duty.

REPUBLIC OF IRELAND AND THE EUROPEAN UNION: all purchases are posted using the Republic of Ireland's signed for registered post system, or by courier (purchaser's choice). NO VALUE ADDED TAX or import duty is payable by customers in the Republic of Ireland or the EU.
